In compliance with the Hon'ble High Court's letter, communicated vide No. HC. VI-02/2015/156/STT, dtd. Guwahati 6<sup>th</sup> December/2017, a monthly meeting for the month of July, 2018 has been convened on 01-08-2018 amongst the Judicial Officers of this District Judiciary to assess the performance of the Courts under Lakhimpur District Judiciary in disposing of old pending cases.

In the Court of the District & Sessions Judge, Lakhimpur, North Lakhimpur, there are total 28 nos. of cases are pending for more than 5 (five) years as on 31-07-2018. Special (PC)-06, Special (NDPS)-01, Sessions Cases-13, T.S. (Probate)-02 and C.P.-06 numbers of cases are pending for over 5 years and more in different stages. Most of the cases are at the stage of Evidence or Further Evidence.

As per report of the learned Additional District & Sessions Judge (FTC), Lakhimpur, North Lakhimpur total 05 nos. of cases are pending for over 5 years for the month of July, 2018. Regarding disposal of cases, no such case is disposed of during the month.

It is informed by the learned Civil Judge & Assistant Sessions Judge, Lakhimpur, North Lakhimpur that total 05 numbers of Civil Cases are pending for over 5 years as on 31-07-2018.

As per report of the learned Chief Judicial Magistrate, Lakhimpur, North Lakhimpur, total 70 numbers of cases are pending for over 5 years as on 01-07-2018. Institution during the month is nil. Disposal of such cases during the month is 01. Present status of old pending for over 5 years is 69 as on 31-07-2018. Most of the cases are at the
