Item: *Matter relating to the strengthening of monitoring mechanism for expeditious investigation and trial of cases.*

Resolution: In today's meeting all the members of the Committee were present. The Committee has vigorously discussed on the matter relating to Under Trial prisoners, who are entitled to get the benefit as per provisions of sections 167 Cr.P.C. and 436 (A) Cr.P.C. As per the monthly report submitted by the Ld. Chief Judicial Magistrate, Lakhimpur, North Lakhimpur, regarding holding of Mobile court within the premises of the District Jail, North Lakhimpur on 30-10-2018, it has been stated that UTP's namely Sri SHANKHA DHAR KAKOTI and Sri DEBAJIT BARUAH @ BIREN has been found to be entitled to get the said benefit, u/s 167 Cr.P.C. and u/s 436(A) Cr. P.C. As per the monthly report submitted by the Sub Divisional Judicial Magistrate (M), Dhakuakhana, it has been stated that he had conducted Jail sitting in the District Jail premises on 12-10-2018. There are 11(eleven) numbers of UTPs detained in District Jail, Lakhimpur as on 10-10-2018 under the jurisdiction of Dhakuakhana Sub Divisional Court and he found that one UTP namely Sri ANIL GOGOI falling under his Jurisdiction is entitled to be released under Section 167 Cr.P.C.

In the meeting, the matter regarding requirement of Medical & Health Officer and Pharmacist in the District Jail, Lakhimpur was widely discussed and the Superintendent of the District Jail apprised the Deputy Commissioner, Lakhimpur, Assam regarding the non availability of 1(one) permanent Medical and Health Officer and 1(one) permanent Pharmacist in the District Jail, Lakhimpur, Assam. The ADC, Lakhimpur representing the Deputy Commissioner apprised the members of the Committee, that, an effort to solve this issue will be made at the earliest. As per the reports of the Superintendent District Jail, it has been stated that, there is only one Medical & Health Officer and one Pharmacist, who have been working on deputation in the District Jail, from North Lakhimpur Civil Hospital. As per the report of the Supdt. of Police, Lakhimpur, North Lakhimpur, uploading the database of Investigation Officers in the official website is going on, so that the I.Os are able to respond through the given data(s) in the case of necessity.
