

**MINUTES OF THE MEETING OF THE DISTRICT LEVEL MONITORING COMMITTEE (INFRASTRUCTURE),  
LAKHIMPUR, NORTH LAKHIMPUR, HELD ON 09.01.2019**

The meeting of the District Level Monitoring Committee (Infrastructure), Lakhimpur, North Lakhimpur, is held today, on 09.01.2019 at 04:00 pm in the Conference Hall of the District & Sessions Judge Establishment, Lakhimpur, North Lakhimpur, being attended by Mr. M. A. Choudhury, District & Sessions Judge, Lakhimpur, N. Lakhimpur, Dr. Jeevan B, Deputy Commissioner, Lakhimpur, N. Lakhimpur, Mr. J. Singh, Chief Judicial Magistrate, Lakhimpur, N. Lakhimpur, Mr. Deep Saikia, JE (PWD Building) representing the Executive Engineer, PWD (Bldg.) Division, N. Lakhimpur, and Mr. S. Deka, Asst. Executive Engineer, PWD (Electrical) Sub-Division, Lakhimpur, Assam to discuss and decide in respect of the infrastructure related works of the various projects under the establishment of the District & Sessions Judge, Lakhimpur, N. Lakhimpur, including the residential Quarters of all the Judicial Officers.

In today's meeting the members present of the District level Monitoring Committee (Infrastructure) reviewed all the ongoing Infrastructure works pertaining to the Judicial Court Building at Lakhimpur as well as the residential Quarters of all the Judicial Officers.

In the meeting, the Committee discussed regarding the encroachment in the land of the Judicial Officer's Quarter (Assam type), currently occupied by Sri Narayan Kuri, Secretary, DLSA, Lakhimpur, North Lakhimpur. It has come to the knowledge of the Committee that, one Sri Uma Kanta Sharma whose house is situated in the northern side, adjacent to the quarter currently occupied by Sri Narayan Kuri, Secretary, District Legal Services Authority, Lakhimpur, North Lakhimpur, has encroached the land of the Judicial Officer's Quarter, currently occupied by Sri Narayan Kuri, Secretary, DLSA, Lakhimpur, North Lakhimpur quarter by demolishing the previous wall measuring around 13 x 12 ft. on the North-western side of the Quarter. The Committee has unanimously entrusted Sri Deep Saikia, Junior Engineer, PWD (Bldg.) division, North Lakhimpur, to get the measurement of the whole land of the quarter in co-ordination with the Circle Officer, North Lakhimpur Revenue Circle, and if it is found that, the land is less than the total amount of land of the quarter, then Sri Deep Saikia, Junior Engineer with the aid and advice of the Committee will take immediate action against the encroacher, Sri Uma Kanta Sharma to recover the occupied land immediately and he is to submit his report before the Committee on 21.01.2019.

The Committee has also unanimously taken the decision to engage the Court Manager of the Lakhimpur District Judiciary, Lakhimpur, for proper accomplishment of the duty entrusted upon Sri Deep Saikia, Junior Engineer, PWD (Bldg.) Division, North Lakhimpur.

The Committee has also discussed regarding development of the undergoing construction of boundary wall of the Judicial Court building. The Committee has selected the Entrance gate of the Judicial Court Building from the catalog of the design of Entrance Gate "PFB-49" to be constructed at the entrance of the Judicial Court building.
