

MINUTES OF THE MEETING HELD ON 11-07-2019 AT 04.00 PM IN THE OFFICE CHAMBER OF THE DISTRICT & SESSIONS JUDGE, NORTH LAKHIMPUR, LAKHIMPUR, ASSAM.

In pursuance of the letter of the Inspector General of Prisons, Assam, vide letter No. PRI.76/2009/29, Guwahati, Assam, the 20th June, 2013, a meeting has been convened in the Office Chamber of the District & Sessions Judge, North Lakhimpur, Lakhimpur, Assam on 11th JULY 2019 at 04.00 pm under the chairmanship of the District & Sessions Judge, Lakhimpur, North Lakhimpur, Assam.

During the course of discussion made on various aspects of reviewing the cases of the Under Trial Prisoners (UTP's) detained in the District Jail, North Lakhimpur, the Committee has taken up the cases mentioned hereunder for appraisal in which the UTPs are reported to have been detained for (i) more than 1(one) year but less than 2(two) years (ii) more than 2(two) years and above, and observed as follows:-

(I) UTPs detained (as on 11/07/2019) for more than 1(one) year but less than 2 (two) years:-

01. UTP Sri Badal Gorh has been detained in the District Jail, North Lakhimpur since 08-08-2017 in connection with Sessions Case No. 08(NL)/2018, u/s 302 of the IPC pending in the Court of the Sessions Judge, Lakhimpur, North Lakhimpur, Assam. The case has been posted on 22-07-2019 fixing for *Evidence of I.O.* The accused /UTP has already been granted bail on 07/11/2017.
02. UTP Sri Bulen Mura @ Kulai has been detained in the District Jail, North Lakhimpur since 30-10-2017 in connection with Sessions Case No. 205(NL)/2017, u/s 302 IPC of the IPC pending in the Court of the Sessions Judge, Lakhimpur, North Lakhimpur, Assam. The case has been posted on 22-07-2019 for *Judgement.*
03. UTP Sri Dhan Bahadur Lama has been detained in the District Jail, North Lakhimpur since 05-11-2017 in connection with Sessions Case No. 25(NL)/2018, u/s 325/448/302 of the IPC pending in the Court of the Sessions Judge, Lakhimpur, North Lakhimpur, Assam. The case has been posted on 29-07-2019 for *Evidence of I.O.*
04. UTP Md. Hussain Ali has been detained in the District Jail, North Lakhimpur since 05-01-2018 in connection with Spl Case No. 13/18, u/s 376 IPC, r/w 4 of POCSO Act, pending in the Special Judge (L), North Lakhimpur, Assam. The case has been posted on 24-07-2019 for *Arguments.*
05. UTP Md. Atabur Rahman has been detained in the District Jail, North Lakhimpur since 07-01-2018 in connection with, SPL. NDPS Act Case no. 01/2018 u/s 20, r/w 22, 29 of NDPS Act pending in the Court of Special Judge (L), North Lakhimpur, Assam. The case has been posted on 22-07-2019 for *Further Evidence.*
