

MINUTES OF THE MEETING HELD ON 16-05-2019 AT 04:00 PM IN THE CONFERENCE HALL,  
LAKHIMPUR DISTRICT JUDICIARY, NORTH LAKHIMPUR, LAKHIMPUR, ASSAM.

A meeting has been convened on 16-05-2019 in the Conference Hall, Lakhimpur District Judiciary, North Lakhimpur, Lakhimpur, Assam at 04:00 PM, under the chairmanship of the District & Sessions Judge, Lakhimpur, North Lakhimpur. The meeting has been convened **to sort out the issues relating to Delay In Investigation and Trials**, in pursuance of the Order dtd. 05.08.2013 passed by the Hon'ble Gauhati High Court, in W.P. (C) (Taken up) No. 4299/2006.

In the meeting, the matter of pending cases in the various Police Stations of the district of Lakhimpur, Assam, beyond 90(ninety) days has been discussed. As per the report received from the O/O Superintendent of Police, Lakhimpur, Assam, regarding the reasons for pending cases in various Police Stations of Lakhimpur district, for the month of **April 2019**, it is noticed that there are a total of **1515** nos. of cases pending beyond 90(ninety) days. It is also reported that out of aforesaid pending cases a total **148** nos. of cases are pending in various Police Stations of Lakhimpur district due to non-submission of Injury Report/Medical Report and **65** nos. of cases are pending due to non submission of Postmortem Report from the concerning authorities. In this regard the District & Sessions Judge, Lakhimpur, Assam requested the Jt. Director of Health Services, Lakhimpur North Lakhimpur, Assam for taking necessary appropriate steps for furnishing the pending PM report for cases, at the earliest for speedy disposal of such cases. In this connection the O/O Superintendent of Police has also furnished a letter before the District & Sessions Judge, Lakhimpur, Assam addressed to the Jt. Director of Health Services, Lakhimpur,

North Lakhimpur, Assam wherein a detailed list of cases which are pending for non-furnishing of PM reports has been provided. The Jt. Director of Health Services, Lakhimpur, North Lakhimpur apprised the members of the Committee that they have already initiated the process of furnishing of pending PM reports at the earliest. It has also been reported that altogether a total of **220** nos. of cases are pending in various Police Stations of Lakhimpur district due to non- handing over the Case Diaries by the respective Investigating Officers either due to their retirement or death and in this regards necessary steps have also been taken for early disposal of such cases. It has also been reported that total **11** nos. of cases are pending in various Police Station of Lakhimpur district due to non-receipt of prosecution sanction and in this regard, a *District Level Screening Committee* is already formed for taking necessary steps for quick submission of such Prosecution Sanctions. It has also been reported that **37** nos. of cases are pending in various police Stations of Lakhimpur district due to non –receipt of FSL Report and **112** nos. of cases are pending due to non- recovery of the victims and necessary steps have already been initiated in this regard.

Further, this Committee has decided to take necessary steps for *uploading of this Report in the official website* of the Lakhimpur District Judiciary, Lakhimpur, Assam.

With these discussions, the meeting held today on 16.05.2019 concludes with vote of thanks from the Chair.
