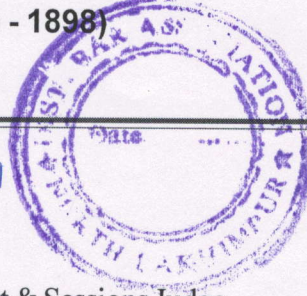

Hon'ble Madam,

With due respect and in inviting reference to the subject cited above the following resolutions are taken to prevent the pandemic Covid-19 by the Lakhimpur District Bar Association.

This is for yours honour's kind information and necessary action.

- (1) As the Hon'ble Gauhati High Court has restircted, Court functioning with staged roster and issued certain directions so as to prevent the pandemic Covid-19.
- (2) As the court will remain opened it will be different for the Advocates if the Bar Library is not opened the Advocates will have no place to sit and there is no other parking places for cars and motor cycles etc.
- (3) So we hope that your honour will allow us to keep open the District Bar Association.
- (4) Further we are taking the following precaution for the prevention of pandemic Covid-19 as the guideline issued by the Government time to time and will restrain the outsiders to enter into District Bar premises except one litigant who want to meet the Advocate.
- (5) All the Advocates will put their signatures on the daily register kept at the entrance of the gate of the Bar Library along with their telephone numbers.
- (6) The Advocates will wear Musk covering the nose and mouth and maintain social distancing.
- (7) In between chairs of the Bar Library one meter distance will be maintained and the Bar Library will be fully senitised.
- (8) The Library of the Bar Association will remain closed.
