

MINUTES OF THE MEETING OF THE DISTRICT LEVEL MONITORING COMMITTEE,
LAKHIMPUR, NORTH LAKHIMPUR, HELD ON 07.06.2017 AT 4.00 PM IN THE OFFICIAL
CHAMBER OF THE DISTRICT & SESSIONS JUDGE, LAKHIMPUR, AT NORTH LAKHIMPUR.

The meeting is presided over by the District & Sessions Judge, Lakhimpur, North Lakhimpur, who is the Chairman of the District Level Monitoring Committee, Lakhimpur. All the members of the Monitoring Committee, who are present in the meeting, have actively taken part in the discussion regarding infrastructure related works with respect to PWD (building) and PWD (Electrical).

This committee has discussed the project of repair/ renovation of Judicial Court building at North Lakhimpur for an estimated amount of Rs.70,79,500/- only. It is informed by the Executive Engineer, PWD (Bldg.) division that administrative approval has been accorded and re-allotted to the contractor. This Committee has also discussed the project of revised estimate for construction of Lift and Ramp for RCC Lower Judicial Court building at Dhakuakhana, which is estimated at Rs.22,22,000/- . It is informed that the estimate has already been submitted to the Commissioner & Special Secretary to the Govt. of Assam, PWD (B) division. This Committee has also discussed the project of construction of outside public toilets for ladies and gents with running water facility in the Judicial Court complex of North Lakhimpur, which is estimated at Rs.16 Lakhs. It is informed by the Executive Engineer, PWD (Bldg. Divsn.) that the work is in progress. This committee has also discussed the project of construction of RCC building for ADR centre at Bowalguri, North Lakhimpur, estimated at Rs.1,59,02,200/- and Rs.1 Crore. It is informed that the estimates have already been submitted to the Chief Engineer, PWD (B) division. This Committee has also discussed the project of repairing of Grade-II and Grade-III Judicial Officers' quarters, which are estimated at Rs.4,99,200/- each. It is informed by the Executive Engineer that

estimates have already been submitted to the Dy. Secretary to the Govt. of Assam, PWD (Bldg. & NH Deptt.), Guwahati. This Committee has also discussed the project of revised estimate for construction of campus drain and fixing of chequered tiles in the premises of Judicial Court building at North Lakhimpur, which is estimated at Rs.25,63,500/- . It is informed that the estimate has already been submitted to the Dy. Secretary to the Govt. of Assam, PWD (Bldg. & NH deptt.). This Committee has also discussed the projects of repair / renovation of Grade III Judicial Officer's quarters. It is informed that administrative approval have already been accorded. This committee has also discussed the project of brick boundary wall at back and right side of Judicial Officers' quarters and staff quarters campus at Lower Judicial Court, Dhakuakhana, which are estimated at Rs.26 Lakhs. The Executive Engineer has informed that both the matters are pending in the Judicial Deptt. Secretariat. With regard to the project of vertical extension of brick boundary wall of Judicial Officer's quarter at Bantow, North Lakhimpur, and at Judicial Court campus, North Lakhimpur, which are estimated at Rs.9,54,400/- only and Rs.12,67,700/- only, the Executive Engineer has intimated this Committee that the estimate for the project work at Bantow, has already been submitted to the Dy. Secretary to the Govt. of Assam, Judicial department, and the estimate for the project work at Judicial Court campus, North Lakhimpur, has been submitted to the Superintending Engineer, PWD (B) circle, Tezpur. This Committee has also discussed the project of installation of Cooling devices (Air Conditioners), and it is informed by the Executive Engineer, PWD (Elect.) division, that the works are in progress. This Committee has also discussed the project of installation of Geysers in the official residence of the Judicial Officers and it is informed that the work has already been completed. With regard to the project of installation of DG sets in the official residence of the Judicial Officers, electrical repairing works at Judicial Officers' quarters at Dhakuakhana, installation of fire detection system and protection system to the District Court complex building at North Lakhimpur, it is informed that these matters are pending at Judicial Department, Govt. of Assam. With regard to the project of providing Air Conditioners and other important lighting arrangements to Sub Divisional Judicial Court at Dhakuakhana, it is informed that financial sanction has already been approved.

With these discussions, the meeting held today on 7th day of June, 2017 has been concluded with vote of thanks from the chairman.


