
In pursuance of the Hon'ble Gauhati High Court letter No.HC.XXXVII-16/2021/457/R.Cell dated 19.10.2022 Sri Hirok Jyoti Saikia, S/o Nandeswar Saikia, Vill-Perabhari, P.O-Bongalchuk, P.S North Lakhimpur, Dist-Lakhimpur, Pin-787023, State-Assam has been provisionally selected by the Hon'ble Gauhati High Court for the post of Lower Divisional Assistant (LDA) vide Notification No.HC.XXXVII-16/2021/447/R.Cell dated 30.09.2022 and directed to initiate the police verification process after issuance of the appointment letter and hence, aforesaid candidate is hereby appointed as LDA Grade-III in the Pay Band Rs.14,000-70,000/- Grade Pay Rs.6,200/- in the Pay Band-III as per Assam Service (Revision of Pay) Resolution' 2017 plus other allowance admissible from time to time w.e.f the date of his joining in the post under the establishment of Chief Judicial Magistrate, Lakhimpur, North Lakhimpur subject to Police Verification report.

The service of the aforesaid candidate shall be governed by the "New Define Contribution Pension Scheme" issued by the Govt. of Assam. He has also to submit undertaking to that effect at the time of joining.

Further, he shall join in the new assignment within fifteen(15) days in the office of the Sub-Divisional Judicial Magistrate(M), Dhakuakhana, Lakhimpur from the date of communication of this order and shall report to the undersigned.

His appointment is purely temporary and is liable to be terminated without assigning any reason thereof.


This order will come into force w.e.f the date of joining in the establishment of undersigned.
