**EXTENSION OF DATE FOR AUCTION NOTICE FOR SALE OF
OLD ARTICLES/ FURNITURE**

The office of the District & Sessions Judge, Lakhimpur, North Lakhimpur will be auctioning the condemned articles/furniture on "AS IS WHERE IS BASIS" on 07.01.2023 at 2:00 p.m. in the premises of the District Judiciary, Lakhimpur. For inspection and other details in respect of the articles/furniture, interested parties can visit the District Judiciary, Lakhimpur on 04.01.2023 and 05.01.2023 between 03:00 p.m. to 4:15 p.m. (in 2nd half).

TERMS AND CONDITIONS

1. The bid will be confirmed in favour of the person quoting the highest rate above the base value decided in respect of the articles. The auction will be held in the District Judiciary Complex, Lakhimpur.
2. The bidder shall submit written bid in closed cover in the prescribed proforma (Annexure-A) with all the fields filled up properly in BLOCK LETTERS, with non refundable court fee stamp of Rs. 8.25/- only, on or before 06.01.2023 at 04:00 p.m. The bidder interested to bid should bring proof of identity. The written bid shall not be less than the Reserve/Base Price of the articles as mentioned but may be more than that.
3. At the time of auction, no bidder shall be permitted to bid for articles for an amount less than the Reserve/Base price of the particular articles. The highest bidder will be selected.
4. 50% of the bid amount is to be deposited by the selected highest bidder immediately on the spot whose bid will be provisionally accepted by way of cash. If the amount is not deposited, the said bid will be forfeited and that articles will be put in auction again and the bidder will be debarred from participating in auction further.
5. On final acceptance of the bid, the remaining 50% amount is to be deposited by the highest bidder within one week of communication of the acceptance to him/her, failing which 50% amount already deposited shall stand forfeited and articles will be sold in auction. On deposit of full and final payments, the auctioned articles will be handed over to such bidder.
6. The office of the District and Sessions Judge will deal with bidder directly and no middlemen/agents/commission agent etc. would be allowed to represent the bidders and the middlemen/agents/commission agent etc. will not be entertained by the office. At the bidding,

- any bidder trying to form cartel with other bidders to otherwise influence the bidding process shall be evicted and stern action as per law will be taken.
7. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money already deposited by him/her shall stand forfeited.
 8. The District & Sessions Judge, Lakhimpur, North Lakhimpur, in its discretion, reserves the right to reject or accept any or all the bids, partly or completely, at any time without assigning any reason there for. The decision of the Board conducting the auction shall be final.
 9. It shall be presumed that the bidder has fully inspected the articles/furniture before the auction. The District and Sessions Judge, Lakhimpur, North Lakhimpur and Board shall not be responsible and shall not entertain any complaint in respect of any defect in the article/ furniture.
 10. The Officers/staff of the District Judiciary and their family members shall not be permitted to participate in the auction.
