In pursuance of the Hon'ble Gauhati High Court's Notification communicated Vide No. HCXXXVII-33/2633/2015/R.Cell dtd. 08-06-2017, Letter No. HCXXXVII-33/2015/2777/ R.Cell dtd. 04-08-2017 and Letter No. HC XXXVII-33/(Pt-I)/2015/118/ R. Cell dtd. 09-03-2018 and in view of the police verification report and the medical fitness certificate received from the concerned authorities, Sri Surajit Paul, S/o- Lt.
