District and Sessions Judge (FTC), Lakhimpur, North Lakhimpur will submit confidential report monthly of his conduct and performance to the undersigned.

The order of suspension dated **04/03/2022** vide letter under memo No. **DJL/1770-77/2022** is revoked. The suspension period will be taken into consideration only for the purpose of continuity of service to compute the terminal benefit and not for any other purpose.
