NOTICE INVITATING QUOTATION

Sealed quotation affixing court fees stamps Rs.8.25 (Non refundable) are hereby re-invited from the local intending firms dealing with the Signboard painting works for marking on furniture on or before **09.07.2018** on terms and conditions as follows.

GENERAL TERMS AND CONDITIONS

1. Quotationers shall have to submit photocopy of Registration Certificate, Trade License, Income Tax and GST Clearance Certificate of his/her firm.
2. The Quotation should be submitted in sealed envelope superscribed as **"Quotation for marking of Furniture"**
3. Quotationers are advised to inspect the furniture to be marked.
4. The Quotationer shall mention the cost of each line/item to be marked. Marking shall be done in following manner :-
 - i) "CJM(XY)1" , ii) "CJM(XY)2 , etc. ("XY" is imaginary name. Different letters will be used for Table, Chair, Almirah, etc.
5. Intending quotationers are advised to contact Nazir , office of the Chief Judicial Magistrate, Lakhimpur, North Lakhimpur, for inspecting the furniture to be marked.
6. The Quotation should be dropped in the Quotation drop Box kept for the purpose in the office of the undersigned till 3:00 P.M. of **09.07.2018**. The quotation shall be opened on the same day i.e. on 22.06.2018 at 4:00 P.M. and the proprietor or the representative of the intending firm may be present at the time of opening the quotations.
7. The quotationer shall have to mark the furniture immediately on receipt of such order..
8. The bill shall be paid through bank account, therefore, the quotationer shall have to submit his firm's Current Bank Account No. which should preferably be of State Bank of India.
9. The decision of the undersigned shall be final in all respects.
